- I hereby declare that I use the equipment of KKV (horse, saddle, bridle, the other equipments in the club, tools and other items of furnitures (collectively hereinafter referred to as assets) on my own responsibility and the way how it is intended to use.
- After using the previously recorded, numbered assets, I return it in original, saved state to KKV. I acknowledge that if assets are damaged, misused or lost, I am obliged to pay the damage to KKV.
- I understand that riding and dealing with horses is dangerous recreational activity, which is for persons whose physical and mental skills, as well as the current status allows, in accordance with the safety requirements of KKV to use the assets.
- I consider instructional use compuslory for myself.
- I hereby declare on my own responsibility that I am not under the influence of alcohol ordrugs, my health, physical and mental condition allows the safety use of assets according to the Houserules KKV 03.03.2023! I understand and agree that KKV assets cannot be used by patients with infectious disease or if public health does not allow it.
- I agree to all the areas of KKV facilities of photo or video material or images making and using them according to the relevant legal requirements, I especially agree to the use of them for marketing purposes, or security archiving, recording.
- I declare and agree that if I do not use assets in intended way, according to relevant regulations, safety requirements, as trained, if I make untrue statement or I mislead KKV or I cause damage in myself or in the third person, I am responsible to pay the damage. According to this, I use KKV assets after careful consideration on my own risk, I take my own responsibility.
- KKV in whole or in part is exempted from liability if the damage was caused by an

unavoidable cause, which falls outside the scope of the activities associated with increased risk, or if damage derives from wrong act of the victim.

- Club does not take responsibility in case of possible risks of working around horses or riding horses. I aware of that riding and dealing with horses can be dangerous which the club warned me of. As I participate in the activities of the club, I understood that I took all responsibilities for my life, for possible accidents (horseback, off horse, near of the horse, in the club and outside of the club), for lost properties. In case of accident, I do not ask any compensation from the club, while I know various risks of dealing with horses.
- I understand that KKV corporates criminal liability that my information is not provided to a third party.
- I understand that disclaimer is valid under 18 years of age with the agreement and signature of caretaker, under the age of 16 with the agreement and signature of parent/ guardian. Signing this disclaimer means that KKV can claim caretaker, parent, guardian for compensation if the person causes damage.
- As a parent / guardian I agree that the person in my care and under the age of 18 enters the club and uses its service.
